DAVIS BACON ACT: FAR 52.222-6

This purchase order agreement is subject to the Davis Bacon Act. Please submit certified payrolls weekly as a requirement under this project.

FEDERAL ACQUISITION REGULATION FLOW DOWNS

The following clauses are incorporated by reference into this agreement. The obligations of LJT to the Government as provided in said clauses shall be deemed to be the obligations of the Seller to LJT. Where necessary to make the clauses applicable to this subcontract, "Contractor" shall mean "Seller", "Contracting Officer" shall mean "LJT" and the "Government" shall mean "LJT" or the "Government" whenever appearing in the clauses when a right, act, authorization, or obligation can be granted or performed only by the Government or Prime Contracting Officer. Clauses referenced below shall be those in effect on the effective date of this Subcontract. If there is a conflict or addition in a clause in effect on the effective date of this Subcontract and a clause of the Prime Contract, the Prime Contract clause shall govern.
